

WASB POLICY MANUAL CHECKLIST 2021

Numerous federal and state laws and regulations require school districts to create and adopt policy and/or procedures/guidelines. The following list identifies some of those key policy requirements and other recommended policy topics. While WASB endeavors to keep this list current and to identify new items to add to the list when appropriate, no such list can be guaranteed to be comprehensive. Thus, the list should be understood to serve as a good place to start when reviewing school board policies.

(✓) = A law or rule, or an expert recommendation, requires the school district to take some action or to make some type of local decision. Policy can be the most appropriate vehicle for these local decisions.

A school board is required to adopt a written policy that specifies criteria for accepting or rejecting such part-time open enrollment applications; A district could address part-time open enrollment and full-time open enrollment in the same policy or in separate policies.]
- ✓✓ Early College Credit Program [118.55 School boards in districts with high school grades are required to establish a written policy governing the timing and method for recovering from a student, or the student's parent/guardian, the student's share of tuition required to be paid when the student is taking a noncomparable Early College Credit Program course for postsecondary credit only (25% of the allowable cost of tuition for the course). A school board may establish a written policy limiting the number of credits for which the school board will pay under the Early College Credit Program and Technical College Course Program [section 38.12(14) of the statutes] to the equivalent of 18 postsecondary semester credits per pupil.]
 - ✓ Technical College Course Program ("Start College Now" Program) [38.12(14), 118.55(7t) A school board may establish a written policy limiting the number of credits for which the school board will pay under the Technical College Course Program [section 38.12(14) of the statutes] and the Early College Credit Program to the equivalent of 18 postsecondary semester credits per student.]

XIV, 111.31, 111.36, 118.13, 118.20 and PI 9] - The new Title IX regulations, which went into effect 8/14/20, include specific responsibilities that school districts have related to responding to alleged or confirmed incidents of sexual harassment (including sexual assault and other forms of sexual violence) that may occur in the district's education programs and activities. These responsibilities include creating and implementing a formal Title IX grievance process to address formal complaints of sexual harassment; providing a Title IX notice to applicants for admission and employment, students, parents or legal guardians of elementary and secondary school students, employees, and all unions or professional organizations holding collective bargaining or professional agreements with the school district; and, ensuring that Title IX Coordinators, investigators, decisionmakers, and any person who facilitates an informal resolution process receive required training.]

- Educating Foster Care Children [Title I of the Elementary and Secondary Education Act, as amended, and the Fostering Connections to Success and Increasing Adoptions Act Districts are required to collaborate with child welfare agencies to ensure educational stability for children in foster care. Districts are specifically required to develop and implement clear written procedures, in collaboration with the local child welfare agency, governing how transportation to maintain children in foster care in their school of origin when in their best interest will be provided, arranged and funded for the duration of the child's time in foster care. Additionally, a district must designate a point of

- contact regarding children in foster care if notified by the corresponding child welfare agency.]

State law also expressly prohibits assisting such persons to obtain a new job. This prohibition could, for example, be included in a district policy addressing employment references and verification.]
