Dear Legislators:

The Columbus School Board is incredibly disappointed and frustrated with the Joint Finance Committee's (JFC's) state education budget approved on Thursday, May 27. The JFC's approved plan was short-sighted on many levels and will have a number of long-term negative impacts on our district, as well as districts of all sizes statewide. We encourage you to review the Governor's budget for education, to consider the long-term benefits to public education and our communities, and to support additional funding in the biennial budget above what the JFC approved for public education.

Four specific areas of the education budget are of special interest to us:

1. Pupil Count Mitigation – due to various family decisions related to the pandemic, school districts saw an unprecedented movement of students from the district from 4K-Grade 12. The membership number used for a school district's state aid is based on a three-year average. With this three-year average, the decline in enrollment due to non-enrollment in 4K or choosing a K-12 accredited all-virtual option will negatively impact our funding for a number of years. Allowing a freeze of membership used in calculating 2019-20 state aid will allow Columbus to retain \$100,000 annually.
2. Revenue Limit Increase – With the current biennial budget, much of the per pupil increase of \$200 in year one and \$204 in year two, allows us to meet the inflationary needs and maintain the operating budget of our District.
3. Special Education Funding – to meet the needs of our Special Education students, the Columbus School District spends ~\$2,700,000 on our special education program. We receive ~\$750,000 in state aid to offset those costs. A majority of the \$1,900,000 in costs come out of our general operating budget. Increasing the state's reimbursement rate to 50% would free up over \$530,000 in our general operating budget to address learning needs and opportunities for all students.
4. Mental Wellness - The social and emotional impacts of the pandemic on school-age students is widely acknowledged. In planning to serve the needs of our 1300 students, surveys indicate that the district has a need for additional school counselors, school psychologists, social workers, and access to third-party resources. None of these essential positions can be filled with the cuts to state education funding as approved by the JFC. It is unknown how long students will need additional resources to recover from the disruptions of the pandemic. It is obvious that failing to provide the resources for students to achieve socially, mentally, and academically is simply robbing them of the education they deserve. School districts cannot help put people back to work without the funding for the positions needed to meet student needs.

Most importantly, the JFC's education budget fails to maintain required state K-12 spending and puts federal funding at risk for all districts. By cutting state funding for ongoing operations because federal pandemic money was available, the JFC is burdening districts with an ongoing shortfall of operating money after pandemic expenses are met. The Columbus School District relied on one-time federal pandemic funding to assist in covering the unexpected expenses incurred to address pandemic needs from March 2020 through the 2020-21 school year. We incurred significant unexpected expense to:

- Execute building management protocols to provide a safe, and healthy learning environment for students and staff.
- Provide the most equitable education for students who lacked adequate internet access. Our District incurred \$100,000 in hot spot expenses alone to provide reliable internet access to students and staff.

As our school district continues to anticipate the future needs of our students and staff and recover from the financial impacts of the pandemic, we need your help in supporting the Governor's budget for public education.
