Wisconsin Students Named U.S. Presidential Scholars

our Wisconsin students have been named 2025 U.S. Presidential Scholars.

The U.S. Department of Education recognized 161 high school seniors in September for their accomplishments, the arts, and career and technical

education. Wisconsin's four honorees are Shilpa Kumar, of Brookfield East High School; Joshua Masslich, of Cedarburg Senior High School; Leonard Whipp, of West De Pere High School; and Madison's Andrew Jimenez, of eAchieve Academy. □

Nearly Half of Wisconsin Students Meet or Exceed Expectations

MADISON - Standardized assessment results released Sept. 25 by the Wisconsin Department of Public Instruction show a slight increase in student performance in both English language arts and mathematics during the 2024-25 school year, according to a DPI press release.

According to data from the Wisconsin Student Assessment System — which includes the Forward Exam, Dynamic Learning Maps, the PreACT Secure and the ACT -47.7%of students in all tested grades met or exceeded expectations in ELA, while 48.6% did so in mathematics.

"While these test scores give us some insight into how our kids are doing academically, they represent a snapshot from a single day and are only one piece of the puzzle," State Superintendent Dr. Jill Underly said in the DPI press release. "Recruiting and retaining great teachers in our classrooms is one of the most powerful ways we can help all kids succeed."

The Forward Exam assesses students in grades three through eight in ELA and mathematics. In the 2024-25 school year, public school students showed a slight improvement in reading performance, with overall Forward scores in reading rising by 0.3 percentage points over the previous year. On the ELA portion, public school students saw a 0.5 percentage point increase in performance. In mathematics, public school performance dipped by 0.3 percentage points. □

E-Rate Funding for Wi-Fi Hotspots on School Buses Ends

n Sept. 30, the Federal Communication Commission voted to end funding through the E-Rate program for Wi-Fi hotspots on school buses. This funding source was established in 2023 by the former FCC administration after COVID-era programs, authorized by Congress, establishing funding for these hotspots expired. Hotspots installed on school buses are designed to allow internet connectivity for students to do classwork while in transit, particularly in large rural districts where students can be on buses for up to an hour or more.

The new FCC chairman Brendan Carr in a press release cited his belief that the rules implementing this funding source through E-Rate were beyond the statutory purview of the FCC and would allow students to use the internet unregulated and unsupervised. The Wi-Fi hotspots connect to a schools' server and are required to have filters and other safeguards to comply with the Children's Internet Protection Act.

Chair of the New Speaker's Task Force on Protecting Children Comments on the Goals and Scope of Their Work

Recently the Assembly GOP, led by Speaker Robin Vos (R-Rochester), announced the creation of four new Speaker's Task Forces. One task force this session will likely have implications for K-12 education, the Task Force on Protecting Children chaired by Rep. Lindee Brill (R-Sheboygan Falls). In a recent interview with the Wheeler Report, Rep. Brill spoke on the committee's focus, goals, timeline and potential challenges.

Rep. Brill's committee will focus on addressing youth mental health crises and the negative impacts of social media. Brill said the committee aims to explore how technology affects children in various aspects of life, including home life, development and exposure to dangers such as pornography, bullying and grooming. The committee plans to meet with experts in these areas to identify where Wisconsin is falling short in protecting children and what legislative actions can be taken to address these issues.

"We know that a majority of children now have phones in their hands, so we know that's really been the avenue to where they're getting information," Brill said. "What can we do to help come alongside parents and schools? What are you seeing that we can be doing from a state perspective, from a law perspective, to help support you in creating a mentally healthy future generation."

Anne Marie Anderson





How Does the WASB Set Our Legislative Advocacy Positions?

You can get involved in shaping our policies!

hether you're a new board member or have served for 20-plus years, if you have engaged with the WASB to any extent, it's likely you have heard the phrase "the WASB is a memberdriven organization." What this means is that our mission, goals, services and more are all crafted and refined in large part through the direction of our members: public school boards.

WASB's official positions on education issues (referred to as resolutions) are no different. These resolutions are refined, evaluated and adopted by our membership and help inform the annual WASB Legislative Agenda. So, what does this process look like from start to finish? And how can you get involved?

■ WASB resolution process

Every year, we ask our member school boards across the state to submit resolutions for consideration. These resolutions are broad policy goals that your board hopes the WASB will adopt as an official advocacy position. Our deadline every year for these resolutions is Sept. 15, and the resolutions submitted must

be discussed and approved as a resolution by your local board. By adopting these resolutions at the local level, it ensures there's general agreement and consensus on what ideas your board wants to submit.

After the submissions from local school boards are received, they move forward to the Policy and Resolutions Committee. This committee is comprised of two school board members from each WASB region, appointed by WASB Regional Directors (elected to serve three-year terms on our board of directors) who review the submissions over the course of several months. During their review, they will either approve, amend (including consolidating into existing related resolutions) or reject proposals. They do this based off of whether a proposal is timely, worthy of debate and merits consideration by the full membership — NOT based on the merits of a submitted resolution or committee members' personal feelings on an issue. In November, the committee meets to finalize the resolutions — either as submitted or amended — that will move forward to our annual Delegate Assembly.



The resolutions advanced to the Delegate Assembly are not advanced with a recommendation from the committee that they be approved by delegates — just that they meet the criteria of being worthy of debate and consideration.

During the State Education Convention in January — which, by the way, is an amazing opportunity that we highly encourage you to attend — we hold our Delegate Assembly. This gives each member school board and CESA an opportunity to vote on the proposals forwarded by the Policy and Resolutions Committee. Each member board gets one vote through an approved delegate. A majority of delegates voting for a resolution result in that resolution becoming an official policy position of the WASB. These resolutions enter our living document known as the "WASB Resolutions Adopted by Delegate Assemblies" and remain in effect unless amended or repealed by a subsequent Delegate Assembly. If your board wants to have a voice in what the WASB is lobbying on, be sure to send a delegate to the Delegate Assembly on Wednesday, Jan. 21, at the Baird Center in Milwaukee.

Every year, we ask our member school boards across the state to submit resolutions for consideration. These resolutions are broad policy goals that your board hopes the WASB will adopt as an official advocacy position.

■ What ideas were submitted for consideration this year?

Court Cases Illustrate the Complexity of FMLA Administration

anaging employee absences is a constant challenge for school districts, especially with substitute teacher shortages and the logistical challenges posed by arranging to have regular employees cover for absent employees. Frequent or long-term absences from a single employee can be especially challenging. However, board members should be aware that some of the absences might be covered by the Family and Medical Leave Act (FMLA), which provides jobprotected leave for certain employees, including those with serious health conditions, those with a family member experiencing a serious health condition, and for childbirth.

This Legal Comment will provide an overview of the federal and state FMLA. Then, it will analyze some recent FMLA cases that serve as important reminders about compliance with FMLA laws. Even though board members are not directly involved in administering family and medical leave, they should have a basic understanding of the state and federal FMLA and the restrictions those laws place on school districts. This short article can only scratch the surface of the overall complexity of FMLA administration, including the manner in which the federal FMLA and the state FMLA interact. School administrators and other supervisors routinely encounter situations involving family and medical leave

that require the school district to navigate complex interactions among local policies and state and federal laws. Applying the various statutes, regulations, policies, and handbook provisions is not a simple task. Sound risk-management principles dictate the designation and ongoing training of well-qualified leave administrators.

Overview of the state and federal **Family and Medical Leave Acts**

Federal FMLA allows a qualified employee to take up to 12 weeks of unpaid leave for qualified reasons. Examples of FMLA qualifying reasons include the birth or adoption of a child, an employee's serious health condition, the need for an employee to care for a spouse, child, or parent with a serious health condition, and specific military situations. Employees can be approved for continuous or intermittent leave. A continuous leave covers a consecutive period of absence. Intermittent leave covers short sporadic absences over a period of time.

FMLA leave protects the employee's job and maintains their employer provided health care coverage. An employee qualifies for federal FMLA if they have worked for their employer for at least 12 months and completed at least 1,250 hours of work during that period.

There is also a Wisconsin FMLA law that is similar but not identical to the federal law. In many situations, federal and state FMLA leave will run concurrently when the leave qualifies under both laws. However, in certain situations, employees might qualify for leave under only one of the two laws. Districts need to comply with the FMLA law that is most beneficial to the employee requesting leave.

Understanding medical certifications

The FMLA permits employers to require a certification from a medical provider when an employee requests FMLA leave for a serious health condition or to care for a family member with a serious health condition. Among other things, these certifications will provide an estimate of the amount of leave an employee might need. This is only an estimate, and employers should be cautious before terminating an employee for exceeding the estimate on the certification. A recent case emphasizes this need for caution.

In Davis v. Illinois Department of Human Services, 1 Dyamond Davis became sick at work and went to Immediate Care, where she found out she was pregnant. Ms. Davis then missed four days of work due to pregnancy-induced morning sickness. When Ms. Davis returned to work, her employer gave her its FMLA packet, which included a medical certification for her doctor to complete. Ms. Davis returned the paperwork, and her doctor indicated how often Ms. Davis would need to

have check-ups throughout the pregnancy and stated that she would need at least six weeks of continuous leave following the birth of her child. The doctor's certification indicated that Ms. Davis's condition would not cause "episodic flare-ups." Ms. Davis was approved for both continuous leave following birth and approved for intermittent leave for her doctor's appointments. She was not approved for leave for "episodic flare-ups" because the certification did not indicate that Ms. Davis would need leave for that reason.

Ms. Davis continued to suffer from morning sickness which caused her to miss work. While working, Ms. Davis told her supervisor that she could not complete the workday due to morning sickness and wanted to use FMLA. The supervisor instructed Ms. Davis to note that her absence was FMLA related on her timecard. Ms. Davis wanted to use her accrued holiday time to cover the four-hour absence and noted that on her timecard. However, she did not realize that she only had 3 hours and 30 minutes of holiday time banked. Ms. Davis also did not note the absence as FMLA related. The employer noted Ms. Davis's absence as unauthorized because she did not have sufficient holiday leave and because her leave exceeded the scope of the doctor's certification because this absence was due to a flare-up. Her certification didn't indicate that she had a need for leave due to flare-ups. The employer implemented its progressive discipline policy, which resulted in Davis's termination. Ms. Davis sued.

The court held that her morning sickness constituted a "serious health condition involving continuing treatment by a health care provider" which entitled her to FMLA leave whenever that serious health condition prevented her from

working. There was no need to determine whether she experienced a "flare up." The employer was well-aware that Davis needed to take intermittent leave for her morning sickness. The court ultimately held that a reasonable jury could find that the employer's conduct constituted unlawful FMLA interference.


Employers must be cautious when denying an employee leave for being in excess of a medical certification. Employers should generally give the employee a chance to complete a new certification in these situations. As the court highlighted in *Davis*, an aggressive approach by an employer can lead to claims of FMLA interference.

■ What constitutes "adequate notice" of the need for FMLA leave

Employees do not need to use magic words to request FMLA. If the employer has reasonable notice that the employee might qualify for

FMLA leave, the employer should provide the employee with FMLA paperwork. After receiving the completed paperwork, the employer will then have the opportunity to determine if the employee qualifies for leave based on the paperwork.

In Valdivia v. Township High School District 214,2 Noemi Valdivia was an administrative assistant in District 214 for six years. Ms. Valdivia received a promotion, but shortly after starting her new position she began experiencing worsening mental health. Ms. Valdivia suffered symptoms such as insomnia, weight loss, uncontrollable crying, and exhaustion. Ms. Valdivia exhibited a clear change in her work habits, including crying at work, and she shared with her supervisor in numerous meetings that she felt overwhelmed. Ms. Valdivia also asked several times to be switched from a 12-month position to a 10-month position, because she felt "time away from the workplace might



help." Ms. Valdivia's supervisor refused her request to change her position. Eventually, Ms. Valdivia resigned from her position. Ms. Valdivia sued the district under the FMLA, claiming the district interfered with her rights because her supervisor failed to give her information about her right to take FMLA leave.

The court held that Ms. Valdivia did have a serious health condition. which rendered her unable to perform her job functions. Furthermore, the court emphasized that the district had constructive notice that Ms. Valdivia might qualify for FMLA leave. The employee's "clear abnormalities in behavior" were sufficient to place the district on notice of Ms. Valdivia's potential serious health condition. Ms. Valdivia's uncontrollable crying at work, and repeated conversations with her supervisor about her insomnia, weight loss, and need to

change to a 10-month position, was constructive notice that Ms. Valdivia may have need of FMLA.

By contrast, in Hubbard v. Illinois State Board of Education,3 a federal court in Illinois held that an employee stating, "I'm sick," "I won't be in today," and "I'm feeling ill" was insufficient to put an employer on notice that the employee might qualify for FMLA leave. This case provides helpful guidance for employers that not every employee illness requires the employer to provide the employee with FMLA forms. However, the Valdivia decision cautions supervisors that they cannot bury their heads in the sand when an employee is exhibiting symptoms of a possible serious health condition that might qualify for FMLA leave.

Conclusion

Board members must be aware of the complexity of FMLA. While districts

might have concerns about staff shortages, employees have the right to utilize FMLA leave as established by law. School districts might need to hire short- or long-term substitutes to cover when employees take FMLA leave. Sometimes employees need this leave with little or no notice. Despite the potential challenges that such absences can create, districts must permit employees to take leave as established by state and federal FMLA laws.
